

**ASSUMPTION OF RISK AND WAIVER OF LIABILITY  
RELATING TO CORONAVIRUS/COVID-19**

In consideration for attending and participating in events sponsored by The Gulf Coast Classic Company and Classic Company at the Harrison County Fairgrounds or John Clark Arena (Rocking H Arena), I hereby acknowledge, agree, and represent on behalf of myself, as follows:

I am aware of the novel coronavirus, ("COVID-19"), worldwide pandemic and that the CDC considers COVID-19 to be extremely contagious and spread mainly from person-to-person, primarily through respirator droplets produced when an infected person coughs, sneezes, or talks and that spread is more likely when people are in close contact with one another (within about 6 feet).

While HARRISON COUNTY, MISSISSIPPI will strive to implement preventative measures to reduce the likelihood of the spread of COVID-19 pursuant to applicable CDC guidelines, I acknowledge and understand that HARRISON COUNTY, MISSISSIPPI cannot guarantee that all CDC, State, local or other guidelines will be followed and/or that I and/or my family will not become infected with COVID-19 during attendance at the Harrison County Fairgrounds or John Clark Arena (Rocking H Arena). I fully understand and appreciate that I am at higher risk of contracting COVID-19 by attending events at the Harrison County Fairgrounds and/or John Clark Arena (Rocking H Arena) and acknowledge that my attendance may, despite HARRISON COUNTY'S efforts to mitigate such dangers, result in exposure to COVID-19, which could result in quarantine requirements, serious illness, personal injury, permanent disability, and death.

I, for myself, and my minor child(ren) \_\_\_\_\_ if applicable, voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury (including, but not limited to, personal injury, disability, and death), illness to my family, and/or myself, and I, for myself and on behalf of my family, spouse, estate, heirs, executors, administrators, assigns, and personal representatives, hereby FOREVER RELEASE, WAIVE, DISCHARGE, INDEMNIFY, HOLD HARMLESS AND COVENANT NOT TO SUE HARRISON COUNTY, MISSISSIPPI, its elected officials, directors, officers, agents, servants, independent contractors, volunteers, affiliates, employees, successors and assigns (collectively the "Released Parties") from any and all liability, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, illness, or injury, including death, that may be sustained by the undersigned, including without limitation as a result of exposure to or infection with COVID-19, whether caused by the negligence, active or passive, of the Released Parties, any third-party using the facilities, or otherwise, while participating in any activity in connection with events held at the Harrison County Fairgrounds and John Clark Arena (Rocking H Arena).

I have read and understand the terms of this Assumption of Risk and Waiver of Liability Relating to Coronavirus/COVID-19 and agree to its terms. If signing on behalf of a minor, I understand that this Agreement is made on behalf of my minor children and/or legal ward(s), and represent and warrant to HARRISON COUNTY, MISSISSIPPI, that I have full authority to sign this Agreement on behalf of such minor(s).
